- 1. I did not receive a response from John Lee or any other member of the Neighborhoods and Community Enrichment Committee regarding the letter that was sent.
- 2. The letter was addressed to Unisses Hernandez because she is the Chair of the committee, which has jurisdiction over education issues.

- 3. Parents had a right to opt-out of the program at Saticoy so this issue is not about preserving parental rights but about some parents wanting to limit the rights of parents who do want their children to participate.
- 4. I was at the protest at Saticoy on June 2, 2023, and was assaulted.
- 5. Calling someone a "groomer" is not "loving" or "kind."
