In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. 2. Council File items for possible Community Impact Statements:
 - a. **[City Clerk Fiscal Year 2026-2027 Proposed Budget](#) (including Pages 113-116) states:**
"To meet the mandatory reduction target, the City Clerk proposes not conducting the Hybrid Neighborhood Council (NC) Elections in 2026-27, which would achieve \$915,000 in savings. With no available vacancies, any alternative salary cuts would necessitate layoffs and inevitably impact the City Clerk's core functions. Furthermore, mandated contractual services - such as the operation of the Council File Management System and interpretation costs for City Council Committee Meetings - cannot be reduced without severely hindering critical services and public access to government.
Proceeding with the \$915,000 reduction from NC Elections will prevent the City Clerk from staffing polling places and processing Vote-By-Mail (VBM) ballots. If NC Elections are postponed, this delay will need to be extended for two fiscal years, as the permanent and seasonal staff who execute the NC Elections also perform all Municipal Election duties, including petition review for candidate certification, ballot initiatives,

and referendums. This postponement would also likely result in current Board Members having to extend their terms from two years to four years, which violates NC bylaws.

Historically, NC Boards have experienced high turnover. The City Clerk anticipates that forcing volunteers who agreed to a two-year term to serve four years will result in a higher degree of turnover for the majority of NCs. Additionally, all 99 NCs include one or two Youth Board members. Postponement will disqualify most, if not all, of these youth, as they will become adults during the extended period.”

and from [Proposed Budget Pages 113-116](#):

“If this office must proceed with offering a reduction, we propose eliminating the funding requested for the implementation of the Hybrid NC Elections (Request A). The funding (\$915,000) provides for the conduct of the At-Polls and Vote-By-Mail (VBM) for up to 99 Neighborhood Councils.

The reduction would eliminate the resources necessary to administer the proposed election model, including funding for: As Needed Salaries (\$554,763), Overtime (\$292,853), and associated Expense Accounts (\$102,384). Services that would be eliminated are the complete conduct of NC elections, which include the ability to fully staff polling places, administer VBM operations, review NC bylaws, create ballots, and provide adequate assistance to stakeholders through the candidate filing, registration, and voting processes.

It should be noted that per section 20.36 of the Administrative Code, this office is mandated to conduct NC elections in odd-numbered years. The same individuals within this office are directly responsible for all Municipal elections operations. The NC Election operations would be negatively impacted. Without proper funding, the City Clerk will be unable to staff polling places and will be unable to process VBM ballots. If the postponement of NC elections occurs, this office would have to postpone for two (2) FYs as all permanent and seasonal staff who work to implement NC elections also assist with all Municipal Election work, including petition review for candidate certification, ballot initiatives and referendums. Further, postponing NC elections will result in current Board Members extending their terms in office which will violate all NC bylaws. Historically, NCs have experienced high turnover of NC Board members. This office anticipates that the majority of NCs will experience a higher degree of Board member turnover as a result of compelling those who agreed to serve a two year term on a volunteer basis to instead have to serve a four year term. In addition, all 99 NCs have one or two Youth Board members. Postponement will result in these youth no longer qualifying for their seats as most if not all will become adults in the interim.

The reduction would hinder the goal to increase the number of candidates and voters since the reduction would limit assistance with candidate and voter applications, certification of candidates, and voter education. It risks damaging stakeholder confidence in the integrity of the entire NC system and could lead to a loss in trust from the public due to the office’s inability to connect with voters, including monolingual and low propensity voters. This would also hinder the City Clerk’s ability to meet its legal obligations set forth in Los Angeles Administrative Code 20.36.

If the resources are not received, the City Clerk will be unable to connect with NC stakeholders to provide information on their eligibility to be a candidate or a voter, further disenfranchising the community, specifically the underrepresented and monolingual population. The ability to offer candidate and voter resources in multiple languages and provide staff at polling locations to assist monolingual stakeholders would be compromised. The elimination of NC elections will disenfranchise the over 2,000 stakeholders who apply each election cycle to become NC Board candidates and participate in local government at the grass roots level as well as disenfranchise the 25,000-40,000 Angelenos who have historically participated in these elections every cycle.

Denial of this package will negatively impact the Make LA Shine initiative. Inadequate funding jeopardizes the City’s ability to successfully conduct the 2027 NC Elections and risks the quality and outcome of approximately 99 NC elections. This reduction would hinder efforts to provide a more inclusive election experience and could result in a loss of trust from the public, NC bylaw violations, and damage stakeholder confidence in the integrity of the NC system as a whole. NCs have rapidly experienced a total of a 50% reduction in their yearly financial allocations. Suspending NC elections will result in the strong likelihood of eradicating NCs and making them insolvent, erasing the commitment from our elected officials to support the work of NCs.”

A legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to paragraph (5), or otherwise be recognized for the purpose of providing public comment. **California Government Code Section 54953.8(b)(6)(B)**.
