

The CSUN Food Pantry's goal is to minimize the academic impact of low food security on our students by providing non-perishable nourishment and essentials, including personal hygiene items. The purpose of this request is for funding to purchase personal hygiene items for distribution to our CSUN students that utilize the Food Pantry. Personal hygiene items are an essential need but often tend to be prohibitively expensive and out of reach for many of our students, who often have to make the tough decisions between items to buy, although all are necessary to maintain regular personal hygiene. Personal hygiene is so important that the lack of hygiene items can force our students to miss class, meetings, or work and this can have a negative effect on their academic and personal lives. If students miss class or work because they do not feel comfortable or confident due to the lack of personal hygiene, he/she can end up not meeting their academic or work requirements, which can eventually have an impact on their ability to graduate. Although we do receive donations of these items at the pantry, they tend to be of small volumes and in low quantities, insufficient to maintain constant supplies for our students. This grant will help support a consistent supply of shampoo, body wash, toothpaste, toothbrushes, toilet paper, and menstrual hygiene products in value-size volumes and in larger quantities, which will aid us in our mission to remove unnecessary barriers on the academic journey and help CSUN students to achieve their ultimate goal of graduation.

This grant will support the purchase of personal hygiene items for the CSUN Food Pantry. Providing these items to our students supports their academic journey and their ultimate goal of graduation. These alum contribute because they are in position to do so, and understand that their contribution is providing a path for current students to graduate and eventually contribute as well.
