#### 7. Public Comments

**Michael Towman** – City of Los Angeles is installing solar powered LED lights between Devonshire and Saticoy and from Victory to Ventura. All the prep work has been done and the lights have been delivered and now we are just waiting for crews to come out and install them. A petition was submitted and the council voted to add Sherwood Forest as a domestic geographic name.

**Rosalva Gonzalez** – Sidewalk repair bill geared towards charter and county cities. It is trying to prevent charter and county cities from pass along to home owners and business owners when a city tree has damaged a city sidewalk. We are looking for community support.

**Glenn Bailey** – At last month's meeting we voted to support this bill. Has LA taken a position on this bill?

**Rosalva Gonzalez** – This will be heard in committee in April and move to Senate in early May.

Jerry Sanders – CSUN parking is overflowing into surrounding neighborhoods from Zelzah to Bianca in between Plummer and Nordhoff. CSUN is overselling parking permits. Last 2 years the parking situation has gotten worse. Some cars are parked for 12 hours or more. I have reached out to campus police and the Devonshire division about this and haven't gotten a response. I don't want to have a 1 or 2 hour parking sign in front of my house. Garbage is being left behind, kids are camping out in their vehicles and they are removing trash cans to create parking spaces.

**Steve Patel-** Suggests exchanging information with Francesca M. Vega the appointed CSUN Faculty/Staff representative.

**Donna** - Chair of Land Use for Northridge South. Wanted to make the neighborhood aware of an elder care facility that's 17545 Parthenia Street. We had 500 in opposition of this facility. We'd like to request the board's support in opposition of this facility as well. It takes away the use of single family units. The facility is 83,000 square feet including 140 units and 70 parking spaces.

# 8. City Attorney Candidate Carmen Trutanich will make a presentation 10 – 15 minutes

Carmen Trutanich – I have been the City Attorney for the last 4 years. We are the law office of the city and anything legal that happens in the city of Los Angeles goes through my office. We have 7,000 lawsuits in this city. We advise the Neighborhood Council. There are two divisions to the City Attorney's Office, Criminal and Civil. Crime is down 23% in Los Angeles. We see 50,000 - 55,000 cases a year and read 80,000 police reports in the Criminal division. The LAPD is doing a phenomenal job in keeping crime down. You can't have a discussion about gun control without discussing gun control law. I came up with an idea to send a letter to everyone who tries to buy a gun that shows the responsibilities of owning a weapon. A study by RANS shows that people are 200% more likely to comply with the law if you notify them ahead of time of their responsibilities. We also need to address mental illness at the state level and Environmental Consumer Protection. In 2012 we had 33 trials and 29 favorable victories. On Medical Marijuana, we drafted an ordinance back in January 2010 and it came back in July 2012 as unconstitutional by the appellate court. The Attorney General stated that if these Marijuana dispensaries are operating pursuant to state law, the feds will leave them alone for people who actually need marijuana to treat illness.
