## 6. Comments from Public Officials - CD12, DONE, LAPD, LAPD

**Semme Park** – Councilman Englander is pushing for a 3 million dollar street bond which would fix all streets in the city of Los Angeles. The city has voted and he's moving forward for the public to be able to file police reports online. Recently opened Eliso Park on Rinaldi between Reseda and Zelzah. Introduced a motion for Planning and Safety, Building and Safety and work on how to preserve horse locations in the Valley. Englander also authored a resolution supporting bill 57 that will increase fines for criminals who remove ankle monitors. Councilman Englander is asking all councils to take a stance on the Planning committee's Mural Ordinance.

**Rosalvo Gonzalez -** Sidewalk repair bill will be heard in assembly on April 10. Currently no opposition has been heard. Must submit a letter of support by April 1. Budget is looking good and revenue is coming in higher than projected. We'll get more answers once May comes around.

## 9. Santa Susana Mountain Park Association Presentation

Luke, Vice President of the Santa Susana Park Association – We've been around for 43 years now and our mission statement is to preserve the Santa Susana Mountains in the Simi hills. Right now we're looking at 15,000 acres that is endangered by development. This is the most important habitat land in Southern California because all the animals that migrate into the Santa Monica

mountains pass through this corridor that's why we are so concerned about it. The property is currently administered by NASA but it's owned by the General Services Agency. It is General Service's responsibility to dispose of the property. There are two entities currently interested in the property: National Park Service and the Bureau of Indian Affairs. We believe the National Park Service is the only agency with the track record and expertise to take care of this property. We believe this property needs to be run as a museum and culture center. Within a year GSA will decide where this property goes. Requesting the board sign a resolution asking the National Park Service to please utilize the GSA process in obtaining this property.
