 - CD12 Jessie Levine represented Council Member Mitchell Englander. Among other announcements she invited anyone in need to reach out to the NC Board or come directly to CD12 for help. She also announced the installation of two new General Managers: Ralph Terraza (FD) and ______ (Transportation) Noted a retired Ambulance was donated to California Emergency Mobile Patrol. Also mentioned National Night Out Tuesday, August 5th- Lego Movie @ Northridge Park.
 - Mayor There was no one in attendance from the Mayor's Office
 - DONE Melvin Cañas thanked those who came early, at 5 pm, to take the Funding Training noting that just three others who will need to complete the Funding Training. He announced the possible need to call a Special Board Meeting in order to finalize the Strategic Plan and approve an Annual Budget, as per the letter. He stated that the Treasurer and 2nd Signatory have already completed their mandated training. - 7. Public comments (3 min. max.)
 - A. Stakeholders Estelle Goldman, Susan Thomas, and others read prepared statements (see agenda item 9, below)
 - B. Bob Bindy addressed the Board seeking support in dealing with property zoning [violations] at 18257 & 18259 Halstead, a single-family dwelling slowly being converted into multi-unit rental property, explaining that first the garage was converted to a "rec room" then plumbing/toilet was added and now the owner is renting the space for \$1,100/month circumventing the area zoning laws. He asked that the PLU committee look at RA1 zoning and the build-up of multi-unit "Build-Outs". AB 1865 (?) deals with the conversion of Single Family Dwelling to Duplexes for rental property.

The matter was referred to the Planning and Land Use Committee. Senate Bill overrides our local zoning regulations – splitting up a residence for rental to students who aren't invested in the community, instead of single family homebuyers who are making a long-term investment. Resident asked for NENC & PLU to meet with Zoning Department officials and address this issue. Kelly Lord, I'll address this issue with the PLU Committee, which had already spoken with Mr. Bindy about it. Nadine McNulty was consulted.

Jessie Levine (CD12) "Call 311 and look up "LA GPS" (?) Steve Patel commented that whoever signed off on that [the garage conversion] there's something *very* fishy about it. Brian Rough observed that addresses may be added onto a property by filling out a form at the local Post Office.

8. Campaign Presentations

Mark Reed, Congressional Candidate – Local roots, married H.S. sweetheart. Federal, State, and County regulations have changed industry in the [San Fernando] Valley, driven businesses out of state or overseas costing stakeholders good middle-class jobs. He said, "Now we need more trade schools [feeding into] industries right here at home. We've lost

Raytheon, Pratt-Whitney, and Teledyne – all off-shored to other countries. Voters have the power to change things. Eighteen years of Brad Sherman's policies have killed jobs in LA."

9. Proposed Verizon Cell Tower at 16324 Lassen St. (Lord)

Stakeholders Estelle Goldman, Susan Thomas, and others – read prepared statements requesting Board support in opposing the proposed 45' Cell Tower (Monopine) to be erected at 16324 Lassen St. in Northridge, particularly in light of the fact that the Notice of Public Hearing listed Mission Hills, Panorama City, and North Hills but failed to include Northridge. (see attachments)

Bob Bindy mentioned Lead-Acid Batteries (posing a public safety issue.) Don ___, spoke out as a pilot using Van Nuys Airport – It's not safe to waive the height restrictions. Brian Rough cited the number of cell towers already in use, stating that they work on "line of sight" basis, and the electro-magnetic-frequencies are known to cause deleterious side-effects. The specifications listed and assurances offered by the original installers have little meaning given that they'll sell the towers to another company that will then expand capacity by installing additional antennae in the extra slots – therefore the estimates and "safe" radiation readings aren't accurate. The new owner won't maintain the equipment [to factory specs] leading to many health concerns.

Susan T stated that this project won't serve NENC stakeholders; it helps the church that gets up to \$20,000/year and Verizon that gets extra storage capacity – but residents will be harmed, not helped. It will be damaging to property values. They asked for NENC Letter of support.

Steve Patel asked about the location (the church next to Heritage School, SW corner of Woodley and Lassen. Steve Patel noted: "The Public Hearing will take place on Tuesday, August 5th. If we don't act NOW, it will be too late." Glenn Bailey made a motion that NENC issue a statement of opposition to this Cell Tower.

Karen objected stating the recommendation should come from the PLU Committee. Kelly indicated that they'd met and discussed the issue but had not taken a vote. Steve Patel, in the absence of this meeting [the Public Hearing] being postponed, we owe it to the stakeholders; we cannot say nothing, or DO nothing (by strictly adhering to committee-referral & recommendation protocol.) He acknowledged that the Land Use Committee hasn't had time to fully study the issue, but emphasized the need for action.

Don Dwiggins suggested that NENC ask the Land Commission for a postponement. Glenn Bailey expressed his concern that the City had failed to properly notify residents (failed to include Northridge residents in the Public Hearing Notification.) There's not enough time or information. We could have a [Special] Board Meeting.

Stakeholder Karen stated that a representative from the PLU Committee could attend the zoning meeting on August 5th, inform them of the improper notification, and ask them to postpone. Steve Patel strongly recommended support of the stakeholders who cared enough to rally around this cause tonight. We can revisit and reconsider the issue later, with more time.

Steve Patel – "Why aren't we being told about these in time to respond?" The 500 foot notification goes out with too little advanced notice for NENC and most stakeholders to respond. Kelly Lord – That would require a robust, efficient Outreach effort to investigate anything in Northridge East, to contact [stakeholders] and identify NENC interests.

- 6. The text of the motion, which Kelly Lord provided, pertains to permitting a wall. (property storage bordering, crowding wall)
- 7. There were no objections from neighboring owners so PLUM committee recommends approval of variance
- 8. Comments: Stakeholder Brian R. stated that this is a work in progress, the storage shed is adjacent to the wall, and expressed his opinion that it should not be approved since it doesn't match the architectural design [of the owner's residence or neighboring homes.] Stakeholder/PLUM committee member, Karen (_?) stated, "The old storage shed was originally properly permitted; the new owner is asking for a new permit and applying for a variance. Alice McCain refuted the objection on the basis of design and appearance; the property is situated within her RE market area and there is no particularly unifying design in the area. The storage shed and carport aren't unsightly or disruptive to the look of the area.
- 9. Kelly Lord restated the motion (2nd Alice M) The motion passed. (7 Yes, 0 No, 3 Abstain, 0 Recused, 4 Absent, 1 ineligible)

Continuation of Agenda Item 8 Campaign Presentations [Candidate arrived at the meeting during the SBM]

Matt Dababneh, CA State Assembly Member — "The State budget is in much better shape today, without passing any bond initiatives. There's the "Rainy Day Fund", Proposition 44, and new rules on Capital Gains stating anything over 8% of the General Fund will go in this (Rainy Day) fund and we're only allowed to withdraw funds after three years of loss or in the event of a Natural Disaster. Simply proposing this raised the State's credit ranking from A to AA3. Previously the cap was set at 5%, now it's set at 10%. This is a complex topic but you can find more information on this subject online. The state needs to allocate more money for the Cal State University system, specifically to increase the number of available classes so that people can actually graduate (with a Bachelor's degree) in two years. He mentioned the Insurance Commissioner and offered assistance through his office in Van Nuys, specifically those having trouble negotiating state programs for assistance. (i.e. EDD) He mentioned two town halls on 8/23 at the Providence Campus and another on 9/6 at El Camino. He offered more good news on the budget via his website and his contact info: matt@mattdababneh.com. He asked for questions. Steve Patel asked about the State's position on a property owners' division of their single family dwelling into student housing rental property. (1866 - SB or AB?) Granny Flats? Matt answered: State law doesn't

circumvent dwellings, but there are NO FREE PASSES. State law won't circumvent local law. He recommended that those concerned contact their local city council member (CD12 – Mitchell Englander) and Los Angeles Department of Building and Safety (www.ladbs.org.) Stakeholder (Former NENC Board Member) Ankur Patel commented on the different economic impacts of High Speed Rail vs. Light Rail, the Water Bond – truly benefiting Big Agri-business, rather than residential ratepayers, \$6,000,000,000 (six billion-dollar) for Central Valley, which has been decimated by the drought. Instead, Ankur Patel called for investment in local ground water and L.A. River clean-up, stating that as the eighth largest economy in the world, California can and must do better. Verify wording

Kelly Lord stated that it would be worth spending extra money to support local, privately owned, business. Steve Patel advocated support of local business but stated it would be more fiscally responsible to opt for the Northridge P.O. as it would cost less money and offer greater access; they have an open box and the \$150 allocation would fully cover this. He continued that Ship & Pack is possible but costs an additional \$100 or more per year. If the Board wishes to consider this would need to be re-agendized. Kelly Lord moved for postponement (2nd YJ Draiman) – A vote was taken and the motion carried.
