

Minutes of the NORTHRIDGE EAST NEIGHBORHOOD COUNCIL (NENC) GENERAL BOARD MEETING Wednesday, January 20, 2016 – 7:00 p.m.

at the Northridge Women's Club, 18401 Lassen St., Northridge, CA 91326

NENC (and all other) Meeting Minutes are a summary; Minutes were not, are not and are never meant to be an exact, verbatim, word-for-word transcript or comprehensive record of what was said at a Meeting. 1. Call to Order (President) and Pledge of Allegiance

President Glenn Bailey called the meeting to order at 7:04 p.m. The Pledge of Allegiance was led by Joseph Seoane.

2. Roll Call and Determination of Quorum

Roll Call was taken by the Minutes Writer. Ten of the 15 Board Members were present at the beginning of the Meeting: Glenn Bailey, President; Kelly Lord, 1st Vice-President; Don Dwiggins, 2nd Vice-President; Joseph Seoane, Treasurer; Nestor Fantini; John Hardy; Alice McCain; Nadine McNulty; Carl Petersen; Max Reyes, Appointed CSUN Faculty/Staff. One Board Member arrived later: Nick Beer. Two Board Members were absent: Jay Draiman, Sec.; and Roland Faucher (both excused). The NENC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is eight, so the Board could take such votes. Thirteen of the 15 Board Seats were filled (by election or appointment). Two Board Seats were vacant (Appointed CSUN Student; and Appointed Youth). b. CF 151543 Proposed Water Rate Ordinance

MOTION (by Mr. Dwiggins, seconded by Mr. Beer): The Northridge East Neighborhood Council supports the City Council File 151543 Proposed Water Rate Ordinance subject to assurances that the Department's increased revenue would not contribute to a transferring of surplus revenues to the City's General fund.

DISCUSSION: Comments were made in support and opposition.

MOTION FAILED by a hand vote of the eleven eligible voters present with three in favor; seven opposed; one abstained (Reyes).

MOTION (by Mr. Dwiggins, seconded by Mr. Beer): The Northridge East Neighborhood Council opposes the City Council File 151543 Proposed Water Rate Ordinance.

DISCUSSION: Comments were made in support and opposition.

MOTION PASSED by a hand vote of the eleven eligible voters present with seven in favor; two opposed; two abstained.

Mr. Bailey said the NENC "will a Community Impact Statement to that effect."

c. CF 151380S3 Aliso Canyon Gas Leak/Los Angeles County Assessor/Property Tax Relief Mr. Bailey read aloud from the City Council File, noting that Northridge is included in the affected area. Mr. Coto clarified that Councilman Englander proposed Motions about the gas leak because of "many requests from Porter Ranch residents." Mr. Lord requested and it was agreed to defer this Item to the next Board Meeting.

MOTION (by Mr. Beer, seconded by Mr. Petersen): The Northridge East Neighborhood Council supports the City Council File 151380S4 Aliso Canyon Gas Leak/Office of Finance/Franchise Tax Board/Property Tax Relief.

DISCUSSION: Belief was expressed that this is premature.

MOTION PASSED by a hand vote of the eleven eligible voters present with eight in favor; two opposed; one abstained (Reyes).

MOTION PASSED by a hand vote of the eleven eligible voters present with nine in favor; two abstained.
