6. Presentations/Guest Speakers

- a. **Councilmember John S. Lee - 12th District Councilmember Lee is the new Chair of the Public Works Committee. He believes it will help him bring more resources to the Council District. One of the big issues right now is the street lights being out due to copper wire theft. Council District 12 was the hardest hit district. In the City of Los Angeles, we had over 400 lights with copper wire theft last year. Attempts by the city to fortify the boxes was not successful. Now they pouring concrete over the boxes to prevent theft. He asked the Neighborhood Council to make a list of the three highest priority locations need for replacing the wires. We put a new traffic signal in at Plumber Street and Darby Avenue and it is now operational. In regards to Dearborn park, the Recreation and Parks staff have been out educating people in regards to the parties and disturbing the neighborhood. Councilmember Lee will be advocating the restoration of Neighborhood Council funds back to \$50,000.00. He wants the Boardmembers to introduce themselves to him if the see him at events and keep in touch. He wants more partnerships with the NC, with shredding events, community cleanups, and other events.**

He wants Northridge East Neighborhood Council to look for other ways in which to partner. In regards to the Reseda offramps. The contractor had not applied for all of the permits in advance. Phase one was 75% complete in mid-December before the rains. The remaining 25% is the installation of new storm drain pipes, which in some areas are as deep as 50ft. completion of the phase is now expected to be mid-April. At that time only one lane will be open. The second phase of the project will be on Rinaldi. We now have Skateland for homeless housing but we are looking for more locations. When Councilmember Lee was elected there were zero beds online for the homeless by the end of this year we are expecting the number to be between 400 and 500 beds. We fought very hard to get the West Valley Animal Shelter back open and running as a municipal shelter. Council member Lee said he would look in to the Mission Hills Shelter. There is a tree program that comes with a grant for three years of watering. The city will be installing informational kiosks ahead of the Olympics. Questions were raised about the kiosks. The cell tower issue was also raised in regards to its location. The Animal Services Commission did ask for a budget increase which would allow the North East Valley Shelter to be run as a Municipal Shelter.
