 - a. CSUN New Student Housing Project and Other Campus Updates Ken Rosenthal, Associate Vice President, Facilities Development & Operations followed by Q&A CSUN received a grant to build programmatic affordable student housing at the CSUN Master Plan site SH4 (southwest of Lassen Street/Zelzah Avenue). The project will be four stories in height and will consist of two adjacent buildings, each having 99 beds. The ground floor of each building will have a lounge, meeting rooms, print station, postal service, and administrative space with the upper floors having traditional freshman suite-style bedrooms and living spaces They are going through the administrative process for taking possession of part of the streets. The Sierra Annex has been renamed Maple Hall. Sierra Hall now needs to be renovated. He also went over some of the other upcoming projects. There will be a Discovery Lab which will engage with younger students. The Hotel is a casualty of Covid. This project is on hold and may not be built due to costs.
